#### 4. MINUTES OF THE PARISH COUNCIL MEETING HELD ON 15th MAY 2023:

Cllr Royle proposed the minutes be adopted; Cllr Hopkins seconded this proposal. Members all voted in favour.

Members voted unanimously in favour.

It was **RESOLVED** that the Annual Governance Statement of 2022/2023 was correct and that the Parish Council was adhering to all the requirements within it. The document was signed by the Chair of the meeting and Parish Clerk.

#### e) ACCOUNTING STATEMENT FOR 2022/2023 AUDIT:

Prior to the meeting the Clerk had circulated the 2022/23 Statement of Accounts.

Cllr Darbishire proposed approving the Accounting Statement. Cllr Royle seconded the proposal.

Members voted unanimously in favour.

It was **RESOLVED** that the Accounting Statement for 2022/2023 was correct and was duly adopted and signed by the Chair of the meeting and Responsible Financial Officer.

#### f) 2022/2023 YEAR END ACCOUNTS:

Prior to the meeting the Clerk had circulated the Accounts for the year ending 31st March 2023. Cllr Hopkins proposed approving the 2022/23 Year End Accounts. Cllr Royle seconded the proposal. Members voted unanimously in favour.

It was **RESOLVED** that the 2022/2023 Year End Accounts were a true record of financial transactions and were duly signed by the Chair and Responsible Financial Officer.
