Proposal: Oak x 1 Reduce

Reason: Damage in branch and potential failure

Reason: Trees have significantly overgrown site.

Site: 8 Bradley Road, Milford-on-Sea, SO41 0AZ

Proposal: Single-storey rear extension with a flat roof and roof lantern; fenestration alterations and use of part of garage as study

Cllr Darbishire proposed Par 1, this vote fell. Cllr Pepper proposed Par 3, Cllr Royle seconded this proposal. All members voted in favour.

PAR 1: We recommend PERMISSION but would accept the decision reached by the District Council's Officers under their delegated powers.

Site: Sedges, Blackbush Road, Milford-on-Sea, SO41 0PB

Proposal: Steel-framed balcony with glazed balustrading, to be accessed from new opening on NW elevation of house; construct steps to rear gardens.

Cllr Pepper proposed a Par 1, Cllr Darbishire seconded this proposal. 3 members voted in favour, 2 against, 1 abstained. Cllr Cullen counter-proposed Par 5, Cllr Royle withdrew his support for Par 1 and seconded his support for Par 5. 4 members voted in favour of Par 5, 2 members abstained. Par 5 was carried.

Proposal: Single-storey rear alterations, demolition of conservatory

Cllr Bennett proposed Par 3, Cllr Cullen seconded this proposal. All members voted unanimously in favour

PAR 3: We recommend PERMISSION

Application No: [25/11052](#)

Site: Land at New Lane, Milford-on-Sea

Proposal: Erection of agricultural barn

Mr. Baker, who is the owner of the adjoining property, was invited to address the committee. Whilst the site plan was being viewed he explained where his property was situated in relation to the proposal. He also confirmed the location of a tractor shed that is already in position.

A brief discussion was held amongst the committee members which included the planning history of the site, the nature of the agricultural activity outlined in the application (lambing) and the already existing structure.

Cllr Royle proposed Par 4, Cllr Pepper seconded this proposal. All members voted unanimously in favour.

PAR 4: We recommend REFUSAL

- This proposal is inappropriate in its size and style.
- The submission of agricultural activity (sheep grazing) does not provide adequate justification for the erection of such a barn.
- There is already a substantial tractor shed in existence on this site which is more than adequate to support the site and its activities. There is no justification for a second building of this size.
- Badger setts exist in this location.
